2. Nomination papers must be delivered by hand to the Returning Officer, Bodicote House, Bodicote, Banbury, Oxon, OX15 4AA between 10am and 4pm on any week day after the date of this notice, but no later than 4pm on Tuesday 4 April 2023.
3. If any election is contested the poll will take place on Thursday 4 May 2023.
4. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Monday 17 April 2023. Applications can be made online: <https://www.gov.uk/register-to-vote>
5. Applications, amendments or cancellations of postal votes or postal proxy votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Bodicote House, Bodicote, Banbury, Oxon, OX15 4AA by 5 pm on Tuesday 18 April 2023.
6. New applications to vote by proxy, except for emergencies, at this election must reach the Electoral Registration Officer at Bodicote House, Bodicote, Banbury, Oxon, OX15 4AA by 5pm on Tuesday 25 April 2023.
7. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer at Bodicote House, Bodicote, Banbury, Oxon, OX15 4AA by 5pm on Tuesday 25 April 2023. Applications can be made online: <https://www.gov.uk/apply-for-photo-id-voter-authority-certificate>
8. Applications to vote by emergency proxy at this election must reach the Electoral Registration Officer at Bodicote House, Bodicote, Banbury, Oxon, OX15 4AA by 5pm on Thursday 4 May 2023. The emergency must have arisen after 5pm on Tuesday 25 April 2023.
